# **Privacy Policy**

Protecting your private information is our priority. This Statement of Privacy applies to ehowe.com and The John K Howe Company Inc. and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to The John K Howe Company Inc. include ehowe.com and Howe. The Howe website is an ecommerce site. By using the Howe website, you consent to the data practices described in this statement.

### **Collection of your Personal Information**

In order to better provide you with products and services offered on our Site, Howe may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number

If you purchase Howe's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services available on the Site. These may include: (a) registering for an account on our Site; (b) entering a sweepstakes or contest sponsored by us or one of our partners; (c) signing up for special offers from selected third parties; (d) sending us an email message; (e) submitting your credit card or other payment information when ordering and purchasing products and services on our Site. To wit, we will use your information for, but not limited to, communicating with you in relation to services and/or products you have requested from us. We also may gather additional personal or non-personal information in the future.

#### **Use of your Personal Information**

Howe collects and uses your personal information to operate its website(s) and deliver the services you have requested.

Howe may also use your personally identifiable information to inform you of other products or services available from Howe and its affiliates.

# **Sharing Information with Third Parties**

Howe does not sell, rent or lease its customer lists to third parties.

Howe may, from time to time, contact you on behalf of external business partners about a particular offering that may be of interest to you. In those cases, your unique personally identifiable information (e-mail, name, address, telephone number) is not transferred to the third party. Howe may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties

### **Automatically Collected Information**

Information about your computer hardware and software may be automatically collected by Howe. #### **Use of Cookies**

The Howe website may use "cookies" to help you personalize your online experience. A cookie is a text file that is placed on your hard disk by a web page server. SSL Protocol

# **Right to Deletion**

- Exercise free speech, ensure the right of another consumer to exercise his or her right of free speech, or exercise another right provided for by law;
- Comply with the California Electronic Communications Privacy Act;
- Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics and privacy laws, when our deletion of the information is likely to render impossible or seriously impair the achievement of such research, provided we have obtained your informed consent;
- Enable solely internal uses that are reasonably aligned with your expectations based on your relationship with us;
- Comply with an existing legal obligation; or
- Otherwise use your personal information, internally, in a lawful manner that is compatible with the context in which you provided the information.

#### **Children Under Thirteen**
